- 5 **Indemnity:** I indemnify my Club, the Regional Centre and Tennis NZ from all claims, losses and expenses (including legal costs) suffered or incurred at any time as a result of, or resulting directly or indirectly from, my failure to observe the constitutions, regulations, policies, manuals, guidelines and reasonable directions of my Club, the Regional Centre and Tennis NZ respectively.
